- 2. This promotion commences at 9:00AM AEDT on 07 April 2022 and closes at 11:59PM AEDT on 31 May 2022 (**Promotional Period**).
- 3. Entry is only open to residents of Australia who are Members of Mouths of Mums and aged 16 years or older who are and remain current Purkle members for the duration of the Promotional Period (Entrants).
