**TERMS AND CONDITIONS**

Competition commences on 07 April 2022 and closes on 11:59AM (AEDT) 31 May 2022 (the "Competition Period"). Open to Mouth of Mums members only.

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Entry into this promotion is deemed acceptance of these Terms and Conditions.
2. This promotion commences at 9:00AM AEDT on 07 April 2022 and closes at 11:59PM AEDT on 31 May 2022 (**Promotional Period**).
3. Entry is only open to residents of Australia who are Members of Mouths of Mums and aged 16 years or older who are and remain current Purkle members for the duration of the Promotional Period (**Entrants**).
